ACT plans to operate a Heyl & Paterson Soil Remediation Unit (SRU) to treat contaminated soils. ACT is located at 2700 Huffman Road, Anchorage, Alaska 99516. The plant will initially be located on the ACT property at the Huffman Road address. However, the SRU is mobile and may be operating at a variety of locations.

ACMP CONSISTENCY REVIEW

The ACT facility will initially be located within the Anchorage Coastal Management District (ACP). Your comments, particularly on the proposed project's consistency with the affected local coastal district management program, are requested.

SUMMARY DESCRIPTION:

The ACT SRU is a new facility. The maximum rated throughput capacity of the plant is 20 tons of contaminated soil per hour. The SRU is equipped with a burner that operates on diesel fuel. The facility also includes one 200 kW diesel-fired engine. The SRU cleans hydrocarbon contaminated soil by processing it through a rotary dryer. Heated air acts to volatilize hydrocarbons that are then incinerated after they pass through a fabric filter to control particulate matter emissions.

The Department has reviewed ACT's proposed project under 18 AAC 50.315(b) and has made a preliminary decision to issue a construction permit to ACT to operate an SRU and associated diesel-fired generator. The permit also allows the operation of equipment associated with soil remediation such as storage piles, crushers, screens, and conveyors.

EMISSIONS:

The SRU and the associated diesel generator have expected maximum emissions during a 10-week operating season of 9.9 tons of Nitrogen Oxides, 6.1 tons of Sulfur Dioxide, 0.7 tons of Particulate Matter, 2.2 tons of Carbon Monoxide, and 0.7 tons of Volatile Organic Compounds. Based on pre-construction review, the permitted air contaminant emissions resulting from the project:

1. Will not cause or contribute to a violation of any State Ambient Air Quality Standard or increment set out in 18 AAC 50.010 and 18 AAC 50.020(b); and
2. Will comply with State Emission Standards applicable to this project.
