**Proposed Changes In Title 3 Regs: HB 83 -- Dealing W/ Securities**

Notice is given that the Division of Banking, Securities, and Corporations in the Department of Commerce and Economic Development, under the authority of AS 45.55.950, proposes to adopt, repeal, and amend regulations in Title 3 of the Alaska Administrative Code dealing with securities in order to implement HB 83, the Alaska Securities Act, which was passed by the legislature. If enacted into law, the regulations effective date will coincide with the effective date of the new Securities Act, October 1, 1999.

Most of the changes to the regulations are intended to implement the anticipated changes in statute made necessary by the National Securities Markets Improvement Act of 1996. To accomplish this, these regulations add and amend provisions detailing how to file registrations and notices for broker-dealers, state investment advisers, federal covered advisers, investment adviser representatives and agents of broker-dealers and issuers. The regulations provide investment adviser representative qualifications, and for books, records, and financial requirements of state investment advisers, federal covered advisers, and broker-dealers. Unethical practices sections for broker-dealers and agents are repealed because those subjects were added as statutory provisions in the Act. The regulations will also adopt numerous miscellaneous provisions required to comply with the new Securities Act.

Changes to registration of securities include provisions for notices for investment company securities and offerings under Regulation D and federal Rule 506. The prospectus format is being deleted from regulations, though the requirement of a prospectus is retained, and various sections are being added, both as new or replacement sections, which are adopted from policy statements of the North American Securities Administrators Association (NASAA). The regulations also amend sections on Regulation D and SCOR offerings.

The regulations make several changes to exemptions from registration to delete the requirement of nonprofit organizations to file notice under AS 45.55.900(a)(11). The proposed regulations also add sections on other provisions requiring exemption notices. The section on fees is amended to provide for flat fees for one year with a second year extension available at the time of registration or notice. The regulations add various definitions, for the most part to accommodate sections adopted from NASAA guidelines. Miscellaneous provisions also allow for compliance with the new Securities Act.

The regulations also adopt provisions for the charging of fees for various registrations or exemption from registration, and notice filings. The division will make reporting forms available for many registration purposes. The rules for hearings are substantially changed and miscellaneous provisions are also provided for to comply with the new Securities Act.

Notice is given that the Division of Insurance, under authority vested by AS 21.06.090 and AS 21.66.410 proposes to adopt regulations in Title 3 of the Alaska Administrative Code, dealing with title insurance, to implement, interpret, and make specific AS 21.66.120, 21.66.310, 21.66.370 - 21.66.390, 21.66.410, and

21.66.420 as follows:

3 AAC 27.301 - 3 AAC 27.399 are proposed to be adopted to state the requirements that must be followed by a title insurance company when submitting rate filings to the division and when charging for a service provided by a title insurance company or title insurance limited producer, specifically:

1. Section 301 states to whom these regulations will apply.
2. Section 310 lists the components upon which title insurance rates may be based.
3. Section 320 indicates the minimum standards that must be used for developing data to support a title insurance rate filing.
4. Section 330 provides for yearly reports to be submitted to the division so that both insurers and the division can begin developing and monitoring information to be used for rate filings that will be required in the future.
5. Section 340 states what a title insurance limited producer must provide to a title insurance company so that the company can comply with section 320.
6. Section 350 allows a title insurance company to offer a short-term rate if such a rate has been filed with the director.
7. Section 360 indicates the conditions under which a title insurance company may offer a discount other than a short-term rate.
8. Section 370 establishes what, when, and how a title insurance company or title insurance limited producer must charge and collect for a class of service it provides that relies upon its title plant or public record.
9. Section 380 states what language must be included on a preliminary commitment.
10. Section 390 states that a listing package or property profile must disclose that it is not a representation of the condition of title to a property.
11. Section 399 gives definitions for terms used in sections 301 - 399.

**Air Quality Construction Permit With Phillips Petroleum Company**

The Alaska Department of Environmental Conservation (ADEC), under authority vested by AS 46.14.170 and 18 AAC 50, proposes to revise the permit terms and conditions of Permit No. 9623-AA007 issued to Phillips Petroleum Company (Phillips) to operate the Tyonek "A" Gas Production Platform (Tyonek Platform), and to authorize combustion turbine replacements.

**APPLICANT INFORMATION:**

The operator of the Tyonek Platform is Phillips Petroleum Company, P.O. Box 66, Kenai, AK 99611. The platform is located offshore in Upper Cook Inlet in south-central Alaska, approximately 40 miles west-southwest of Anchorage in 100 feet of water at mean lower low water; Northwest ¼, Section 6, Township 11 North, Range 9 West, Seward Meridian.

**ACMP CONSISTENCY REVIEW:**

The Tyonek Platform resides in the Kenai Peninsula Borough's Coastal Management District. The Department is reviewing the project for consistency with the Alaska Coastal Management Program (ACMP). Your comments, particularly on the proposed project's consistency with the ACMP, are requested. Comments regarding inconsistency with an affected coastal district's enforceable policy or a state standard set out in 6 AAC 80.040 to 6 AAC 80.150 must identify the enforceable policy or standard and explain how the project is inconsistent.

**SUMMARY DESCRIPTION:**

The Tyonek Platform is an existing offshore platform. It consists of five main decks and includes facilities for natural gas production and transportation, utility systems, and crew quarters. The produced gas is transported to Phillips? Kenai Liquefied Natural Gas Plant located onshore near Nikiski, Alaska. Currently, the allowable emissions at the facility are more than 250 tons per year of nitrogen oxides and carbon monoxide, classifying the Tyonek Platform as a Prevention of Significant Deterioration (PSD) major facility.

Phillips? North Cook Inlet Unit 99 project application seeks approval for the upgrade of two existing gas compressor turbines on the platform and develops owner-requested limits for the facility to avoid classification as PSD major. Phillips requests (1) reducing the hydrogen sulfide and sulfur content of gas and liquid fuels; (2) imposing hourly operational limits on equipment; and (3) imposing fuel consumption limits on equipment.

If a facility has the potential to emit more than 250 tons per year of a regulated air contaminant it can be classified under 18 AAC 50.300(c)(1) as a Prevention of Significant Deterioration Major Facility. This classification results in a more onerous permitting process for these facilities. If the fuel consumption at the facility can be limited to that which prevents the emission of 250 tons of the regulated air contaminant the facility is eligible to be considered for this new General Permit 1A. The new General Permit 1A applic

ation has been streamlined and the permit has been simplified to apply only to diesel electric generating facilities which meet the qualifying criteria set out in the permit.

Emissions: Emissions which will result from these new permits are predicated on the burning of no more than 825,000 gallons of diesel fuel with a fuel sulfur content of no more than 0.5% by weight. Based on AP 42 emission factors a facility consisting solely of diesel electric generators burning this amount of fuel would generate in a typical year 249.15 tons of nitrogen oxides, 29.26 tons of sulfur dioxide, 17.32 tons of particulate matter less than ten microns in size, 53.62 tons of carbon monoxide and 20.33 tons of volatile organic compounds.

Notice is given that the Department of Natural Resources, under the authority of AS 38.05.020, AS 41.17.055, and AS 41.17.080, proposes to amend regulations in Title 11 of the Alaska Administrative Code, dealing with forest practices in Region I. These amendments implement and interpret AS 41.17.010, .087, .090, .098, .115, .116, .118, and .119 as follows.

(1) 11 AAC 95.220(a), Detailed Plan of Operations, is proposed to be amended as follows:

This regulation lists the information that a forest operator must submit to the state forester in a Detailed Plan of Operations before beginning operations. The proposed amendment would specify what information must be submitted with any requests for variation from the riparian buffer standards under AS 41.17.087. It would also require that the Detailed Plan of Operations list the amount of new road construction projected for each proposed operation.

(2) 11 AAC 95.235, Variation Procedures, is proposed to be amended to add a new subsection (d) as follows:

This regulation sets the procedures for reviewing a variation request to harvest timber in a riparian buffer under AS 41.17.087. The proposed amendment adds a new consideration to these procedures. It would direct the state forester to consider the impact of the proposed harvest on non-merchantable trees within the riparian area. It would also allow the state forester to stipulate that a variation harvest protect non-merchantable trees that are needed maintain fish habitat and water quality.

(3) 11 AAC 95.240, Variation from Requirements in Areas Adjoining a Small Streamside Zone in Region I, is proposed to be amended as follows:

This regulation allows the Department of Natural Resources to grant a general variation for timber harvest in small streamside zones on private land in Region I. The current definition is based on stream width at normal channel flow. The proposed definition is based on stream width at ordinary high water. The new definition does not significantly change the width of qualifying streams, but simplifies the measurement method and makes it consistent with other measurement procedures under the Forest Resources and Practices Act.

The amendment would also clarify the procedures for determining how many trees may be removed under a general variation for a small streamside zone. It incorporates procedures that are currently used in the field.

(4) 11 AAC 95.265, Classification of Surface Water Bodies, is proposed to be amended as follows:

Under 11 AAC 95.265(g), operators in Region I, may presume that certain conditions will block passage by anadromous fish. The current regulation defines a blockage as a stream reach of 200' or greater that has an average gradient greater than eight percent. However, this criteria is not reliable for the diverse anadromous species in coastal Alaska. The proposed amendment tailors the blockage criteria to the individual species and life stages of anadromous fish found in coastal Alaska. The proposed criteria are based on fall height, jump pool depth, and stream gradient.

(5) 11 AAC 95.275(a), Uses within a Riparian Area, is proposed to be amended as follows.

This regulation lists activities that can occur in a riparian area without a variation. The proposed amendment would delete removal of downed trees from this list. A variation would be required for removal of downed trees.

(6) 11 AAC 95.280, Slope Stability Standards in a Riparian Area, is proposed to be amended as follows.

Under subsection (a) of this regulation, specific slope stability standards apply to certain riparian areas. This amendment would broaden the area to which these slope stability standards apply in Region I. On private land, it would widen the zone on Type A, Type B, and Type C water bodies, and add a zone along Type D water bodies. On state and other public land, it would add slope stability standards on tributaries to buffered streams.

The proposed amendment would delete the purposes for the slope stability standards from subsection (d)

of this regulation.

Subsection (d)(2) requires operators to leave some timber in certain riparian areas that are not covered by buffers. The amendment strengthens this standard and applies it to the riparian area of small tributaries to anadromous streams that do not have other tree retention requirements under the Forest Resources and Practices Act.

(7) 11 AAC 95.810, Measurement of Distances, is proposed to be amended as follows.

Subsection (3) of this regulation specifies the procedures for measuring the width of a stream at normal channel flow. The proposed changes in 11 AAC 95.240 (above) eliminate the need for this subsection since measurements will now be at ordinary high water rather than normal channel flow. Therefore, this amendment deletes subsection (3).

(8) 11 AAC 95.840, Definitions, is proposed to be amended as follows.

The proposed amendment would add a definition for "ordinary high water mark". The current regulations cross-reference a definition in a different group of regulations. To make it easier to find the definition for forest practices, the text of the definitions would now be included in the forest practices regulations. The proposed amendment would also clarify the definition of "ordinary high water mark" for tidal waters.

The proposed amendment also adds a definition for "fall" because the proposed changes in the definition of presumed blockage to fish passage (see 11 AAC 95.265 above) are based in part on fall heights.

The proposed regulations are the culmination of a three-year process to review the standards for forest practices in Region I. A science and technical committee reviewed existing standards and made a number of recommendations for changes. The recommendations were adopted by the Board of Forestry and proposed as statutory and regulatory changes. The statutory changes were passed by the legislature as Senate Bill 12 during the 1999 session, and signed into law by Governor Knowles. The bill went into effect on June 17, 1999. The regulatory changes support the changes in the statute.
